Terms and Conditions for Sale of condemned Toyota Innova vehicle No. DL2CQ-0862:

- a). The vehicle will be sold strictly on 'as is where is basis'. Vehicle is sold on the assumption that bidder has inspected the vehicle, which is being sold by this Authority and they know what they are buying, whether they have first inspected it or not. No complaint will be entertained after the sale date.
- b). The auction process will be conducted by auction committee of this Authority.
- c). The Vehicle can be inspected on any working day between 10 a.m to 5 p.m.
- d.) Every intending bidder will have to register themselves by way of depositing Rs. 4000/- in cash as security money (refundable) at least 30 minutes before the scheduled time of auction which may be adjusted/refunded later on to the successful/ unsuccessful bidder.
- e). The successful bidder shall have to deposit full payment against their bid as soon as the bid is over in cash or in the form of Demand Draft from any Nationalised Bank in favour of PAO, Department of Legal Affairs. In case of failure to deposit the final bidding amount after adjusting the security money on the spot, the respective vehicle may once again taken up for re-auction on the same day.
- f). The delivery of the auctioned vehicle will be arranged only after the successful bidder submits documentary evidence in support of residential status(Raton Card, Voter Id, Passport /Driving License/Aadhaar Card of any other valid proof of address in case of individual and Registration Certificate in case of firms etc.)
- g). The successful bidder must remove vehicle form NALSA premises with three working days from the date of acceptance of the offer by NALSA failing which penalty of Rs. 200/- per day will have to be paid. If the vehicle is not removed within ten days from the date of auction, the security money will be forfeited by the NALSA and he will have no claim over the vehicle whatsoever.
- h). The successful bidder will make his own arrangement for transport and he will not be entitled to claim any facilities or assistance for removal or transport of vehicle from this Authority.
- i). This Authority will not owe any responsibility for transfer of vehicle and for any other liability for using these vehicle for commercial or any other purpose after sale.
- j). If the bidder resile or fails to observe/comply with any of the above stipulations, the earnest money shall be forfeited by this Authority. The decision of the auction committee for all the purpose shall be final and binding.
- k). The NALSA reserves the right to cancel the auction of the aforesaid vehicle at any time without assigning any reason.
